The Fellowship was formed in 1960 in the wake of the 1959 Billy Graham Crusade to help encourage those lawyers who had made a commitment to Christ during that Crusade.

Since that date the Fellowship has continued to assist Christian lawyers in working out their faith in practise.

Members include law students, law teachers, solicitors from a range of firms, corporations and government departments, barristers and judges.

The work of the Fellowship is organised by a Committee which meets bi-monthly.

Why we exist

The Fellowship exists:

- ▶ to promote mutual encouragement and fellowship among Christians engaged in the legal profession;
- ▶ to promote and stimulate consideration of the gospel of Jesus Christ within the legal profession;
- ▶ to uphold Christian principles in the administration of the law.

What we do

 - ◆ Justice Keith Mason, President of the New South Wales Court of Appeal.
 - ◆ Justice Dyson Heydon of the High Court of Australia.
